- **Introduction** by Alessandro Gronchi (5 mins) welcome to the third virtual TARPSWG meeting and discusses recent updated guidelines and accepted manuscripts from the group.
 - Updated recommendations about the management of primary RPS accepted by Ann Surg Oncol
 - L Pancreatectomy in multivisceral resection for primary RPS accepted by Ann Surg Oncol
 - Mesenteric Sarcoma accepted by J Surg Oncol
 - Invitied review about the TARPSWG program on Curr Opin Oncol
 - Change in differentiation in recurrent Liposarcoma resubmitted to Ann Surg Oncol with minor revision
 - Postnephrectomy Outcomes Following en bloc Resection of Primary Retroperitoneal Sarcoma (RPS) resubmitted to Br J Surg after 1st round of revisions
 - o Dynamic nomogram in RPS submitted to Clin Cancer Res
 - Data Dissemination of the Role of Neoadjuvant Radiation in Retropeitoneal Sarcoma presented at this year SSO annual meeting and being submitted to Ann Surg Oncol
 - Preoperative radiotherapy in patients with primary retroperitoneal sarcoma: EORTC trial (STRASS) vs off-trial (STREXIT) results is being circulated in these weeks and will be submitted to Lancet Oncol
 - STREXIT manuscript about the description of the cohort vis a vis STRASS and reasons for not including patients is being drafted and will be circulated soon.
- Update STRASS 2 (15 mins)-
 - Site activation and accrual status (W. van Houdt)
 - Currently 13 sites activated in Europe, n=5 patients accrued
 - o Akynzeo sub-study was cancelled due to withdrawal from the company.
 - o Update from Australia, Canada, US, Japan (R. Gladdy, K. Cardona, D. Gyorki)



- US: progress as protocol approved by the board, FSA expected by the end of the year
- Canada: Central EC approval received Feb 2021, FSA expected in a couple of weeks, expect 5 sites to activate. Centralized through CCTG
- Australia: contract in progress, hope to open 3 sites and achieve internal funding. Aiming to open the 2nd half of the year.
- Japan: first meeting took place to initiate the collaboration. JCOG board still needs to approve study, FSA expected in 1.5 years
- Q&A for participating centers: There are no extra funds to open other sites/countries if not already planned. However if countries/sites not included were able to find funds to support their participation (which will have to include also EORTC HQs costs), a discussion could be initiated.
- STREXIT- CP Raut, CJ Swallow (10 mins)
 - STRASS 190 patients and STREXIT 831
 - Analysis of
 - Overall survival
 - Abdo recurrence free survival
 - Found no significant difference between STRASS and STREXIT by these two features
 - Goal to do a similar analysis using RESAR vs STRASS2

SARveillance Trial (SART) Update- S Ford (10 mins)

- o International partially randomized patient preference trial of high vs low surveillance
- o Run as a trial within the registry, with a multidisciplinary development team
- Currently 22 international participating sites, funding through a Royal College grant to run and adopted by CRCTU (Cancer Research Clinical Trials Unit) in the UK.
- Primary outcome changed from OS to Quality Adjusted life years (QALY)
- Patient preference arm added- for those patients who declined to be randomized but offer to participate can do so through this arm
- Trial using QLQC30 for Quality of Life assessment
- Next step: repower for QALYs as primary outcome, adjust protocol and formalize # per year to be recruited.

• RESAR Update (60 mins)

- Update of recruitment and status of centralized RESAR data collection/registry/mechanics of registry trials-D Callegaro (7 mins)
 - Currently over 2000 patients recruited, 14% increase over 4 months (added 256 patients from Sept 2020)
 - New RESAR centres:
 - 2 recruiting
 - 5 ready to recruit
 - 2 protocol submitted to IRB
- Currently ½ of the recruitment is by 8 high volume centres
- Revisiting the data dictionary with a focus on pathology- D Gyorki, B Dickson (15 mins)
 - Updating data fields
 - Tumor grading
 - IHC



- Subtype definition
- Ensure alignment with WHO 2020
- Discuss possible consensus statements on approach to RP sarcoma reporting
- Consider new data fields to collect to answer key questions
- Next steps: meeting in a few weeks, update at CTOS TARPSWG meeting
- Inclusion of Primary non resected RPS- D Strauss, CJ Swallow, W Tseng (15 mins)
 - Currently use resectable, borderline resectable and unresectable in determining resectability of case
 - Toronto study on why where non-metastatic primary RP sarcomas not resected? Found that age and multifocality were factors in nonresectable status. Those who progressed on treatment had a worse prognosis. Decision to resect based on biology, patient factors and technical factors
 - Need to standardize and 'speak the same language' when it comes to resectability
 - Discussion on inclusion of unresectable cases in RESAR (W Tseng)
 - Initially only included curative intent case, with a denominator of already resected case
 - Flowchart of data points suggested for unresectable patients including reason for unresectability (anatomic, sarcomatosis, comorbidities/PS, multifactorial), treatment given and response to treatment
 - Discussion on resectability and multifactorial reasons for resection as anatomic, patient characteristics and histology.
 - Suggestion made to create a separate database for these cases rather than incorporate into RESAR existing structure → inclusion in RESAR preferred

RESAR projects update

- Last update version of RESAR and update on the DSA Framework and information on how to be part of it – M Fiore (5 mins)
 - Currently 9 new sites in progress to join Framework Agreement
 - Joining Framework Agreement will be required to participate in ResAntiPath/BISARC/Global PoC: these 3 DTAs will be circulated together (May 2021)
 - Goal of prospective centralization for ready availability of data and data quality monitoring within end 2021
 - Creation of new online platform (with additional features such as randomization tool and pseudoanonymation) with future entry options:
 - Online direct entry
 - Upload from exiting Excel/Filemakeer local files
 - Upload from data repository system

Planned RESAR Projects and Deadlines

- Complexity score project for post op morbidity- M Fairweather (2 mins)
 - No further opt-ins
 - N=1159 patients
 - Data cleaning in process for abstract at CTOS this year
- Biopsy project (BISARC)- S Dimitra (2 mins)
 - o Data collected to 2020
 - Data sharing agreements in progress, estimated timeline of April 2021
- Correlation between anticipated resection vs actual resection (ResAntiPath) - M Fiore (2 mins)
 - Data covering timeframe of 2017-2020
 - o N=19 centres have opted in
 - Data transfer deadline to Milan is June 2021
- Variation in patterns of care (Global PoC)- H Snow (2 mins)
 - Examines consistencies of use of various diagnostic, surgical, neoadjuvant modalities
 - Eligible if entered RESAR data from Feb 2017-Jan 2020
 - No additional data points needed for this study, only RESAR data

- Response evaluation after neoadjuvant chemotherapy for retroperitoneal sarcoma- W Van Houdt (5 mins)
 - o Role of NA chemotherapy remains unclear (role of STRASS2)
 - Primary objective: correlation between radiological and pathological response rate to neoadjuvant systemic therapy
 - Extra data required:
 - Early response evaluation during treatment
 - Response after neoadjuvant treatment
- Benchmarks in RPS F Tirotta (5 mins)
 - Benchmarks in RP Sarcoma Surgery ("Benchmarking-> 'defining best practice')
 - Aim: To define benchmark criteria for best achievable outcomes in RPS surgery in order to enable comparative quality assessment
 - Primary outcomes: post operative performance
 - o Subset of RESAR database needed and ASA score
 - o Deadline: 01-May-2021

 - Interim analysis included 16 centres and 270 patients
 - 32 centres included for final analysis
 - Currently closed to opt in.

 - Currently three projects under development:
 - Trabectedin and XRT in WDLPS and low grade DDLPS (presented by Dario)
 - Role of XRT in recurrent RPS (Angela Hong working on prospective study)
 - SBRT for abdominal recurrence- REC study to start (Andrew Bishop and Mateusz Spalek)
- Translational Research Committee- R Gladdy (5 mins)
 - Plan moving forward to:
 - Develop important biologic questions, protocols approved by TARPSWG
 - Participate in correlative studies
 - Translational studies with STRASS1 samples
 - LPS biology focus
 - o STRASS2 Translational Research- Response to therapy needs to be evaluated
 - Need to harmonize biobanking protocols at expert centres, focus on abdominal sarcomas

 - 94% are academic hospitals
 - 76% of centres have weekly tumour boards
 - All operate on RP Sarcoma
 - Discussion on what makes a centre of expertise?
 - # cases per year?
 - Weekly multidisciplinary tumour boards?
 - PEER Review
 - Consensus survey for a centre of excellence may be a good follow up survey to the current TARPSWG survey
